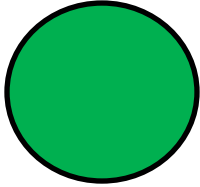
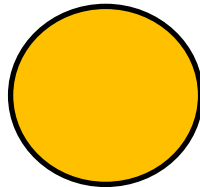


COVID/Health Color Chart

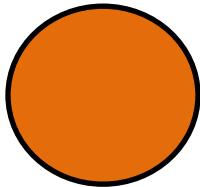
At Camellia, it is our sincere desire to continue managing the COVID Pandemic in as normal a way as possible. We want to continue to provide quality care and a high-functioning learning environment while at the same time remaining cautious and aware of what is going on with our health around us. Going forward, we will be following a tiered color chart that can be changed quickly based on the current health needs of the center. The chart is featured below. Our current color will be posted in three places: the top right corner of the front door, the sign in-out computer, and in the corner of our website. It will be updated as the need arises. When there is a color change, you will be notified by a "Remind" message.



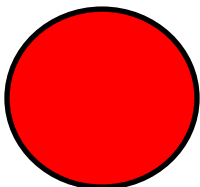
- Infection rate/risk is LOW.
- Masks are optional.
- The building is open to staff, students, families, & visitors. Center Tours open.
- Students remain in peer groups for contract tracing purposes
- Center is cleaned daily and fogged.



- Infection rate/risk is MODERATE (Between 5-10% of staff and student enrollment)
- Masks are REQUIRED (6yr +).
- The building is open to staff, students, families, & visitors with the proper facial covering. Center Tours open, but must be scheduled and facial coverings must be worn.
- Students remain in peer groups for contract tracing purposes
- Center is cleaned daily and fogged.



- Infection rate/risk is HIGH. (Between 10-15% of staff and student enrollment)
- Masks are REQUIRED (6yr +).
- The building is open ONLY to staff & students. Families & visitors will stop at door for drop off/service needs. Center Tours closed. Facial Covering REQUIRED 6yr+.
- Students remain in peer groups for contract tracing purposes. Combining of classes limited. Parties closed to parents and families. Field Trips postponed.
- Center is cleaned daily and fogged.



- Infection rate/risk is DANGEROUS. (More than 15% or classroom outbreak)
- Center will be **CLOSED** temporarily. The length of time will be decided by the WEM Committee and will be based on the exposure rate and the needs of the center.
- A deep cleaning of the center will be performed before being re-opened.

Current Illness/COVID Guidelines

At Camellia, it is our sincere desire to continue managing the COVID Pandemic in as normal a way as possible. We want to continue to provide quality care and a high-functioning learning environment while at the same time remaining cautious and aware of what is going on with our health around us.

The Current CDC Recommendations are as follows:

[People with COVID-19 should isolate for 5 days and if they are asymptomatic or their symptoms are resolving (without fever for 24 hours), follow that by 5 days of wearing a mask when around others to minimize the risk of infecting people they encounter

For those exposed to someone with COVID-19, CDC recommends quarantine for 5 days followed by strict mask use for an additional 5 days. Alternatively, if a 5-day quarantine is not feasible, it is imperative that an exposed person [wear a well-fitting mask](#) at all times when around others for 10 days after exposure.

For all those exposed, best practice would also include a test for SARS-CoV-2 at day 5 after exposure. If symptoms occur, individuals should immediately quarantine until a negative test confirms symptoms are not attributable to COVID-19.]

Based on these guidelines and how they specifically affect our center, the following updates have been made to our COVID Policies and Procedures:

- Students and staff will be separated when sick until they can go home. Student MUST be picked up within ONE HOUR of the parent/guardian being notified.
- Children sent home with the following symptoms require a doctor's note stating they are not contagious and are safe to return to school. **A child being 24 hours symptom free DOES NOT apply for eligibility to return to school at this time. A Doctor's note is required for all children sent home sick with the below symptoms in order to be re-admitted to school.**

FEVER- COUGH- SHORTNESS OF BREATH- CHILLS- FATIGUE- HEADACHE- MUSCLE AND BODY ACHES- NEW LOSS OF TASTE OR SMELL- SORE THROAT- RUNNY NOSE OR CONGESTION- NAUSEA, DIARRHEA, OR VOMITING

- *If an employee, child, or someone in the immediate household is waiting on the results of a COVID test, all parties in the household cannot enter the center until the results are received.*
- Students who **test positive** (vaccinated or not) must isolate for **10 days** following the onset of symptoms or a positive test result and must be asymptomatic or symptoms resolving (24 hours fever-free without fever reducing medication) before returning from isolation. *Because of the age-range of children in our center, we cannot abide by the 5 day mask wearing that would allow students to return after 5 days, therefore all students who test positive will be required to be out of school for 10 days.*
- Students in close contact with a positive COVID case are required to isolate for **10 days**. This applies especially to those who have a confirmed case in their **immediate household**. Exceptions to this required isolation:
 - If the person who has tested positive has medical documentation stating a less than 10 day isolation period, the student can **test for SARS-CoV-2 on the 5th day**. When a **negative result** is received **AND** the student remains **asymptomatic**, he/she can return to school.

- Family members of students who test positive and are coming out of isolation before 10 days with medical documentation, need to wear a mask within the facility through the 10 days following the onset of symptoms or positive test result. This is in line with the above CDC recommendations and is the best line of personal responsibility in protecting our children, staff, and families.
- Employees who **test positive** (vaccinated or not) must isolate for **10 days** following the onset of symptoms or a positive test result and must be asymptomatic or symptoms resolving (24 hours fever-free without fever reducing medication) before returning from isolation. If returning before 10 days with medical documentation, employee will need to wear a mask through the 10 days following the onset of symptoms or a positive test result.
- Contract tracing within the center will be utilized to determine if any other children or employees need to be quarantined due the level of exposure.
- *Failure to report the contraction of the virus with the child, employee, or someone in your household to Camellia WEM will force us to deny further enrollment/employment in our center. The safety and well-being of our families is of utmost importance.*
- All people representative of Camellia WEM, including staff, students, and families are strongly encouraged to set a good example of public health when out and about outside of school. Take the necessary measures to ensure your safety, the safety of the children, the safety of your families, and the safety of the center by wearing a facial covering, frequently washing your hands, staying home when you are sick, maintaining social distancing, and limiting large gatherings.

Personal Responsibility is still our best defense against this virus. If you or your children are exhibiting any COVID symptoms, please remain at home and do not enter the facility.

Failure to report COVID exposure and/or contraction may result in loss of enrollment/employment
